- <u>Resolution ACCG 401(a) Defined & 457(b) Deferred Compensation Plan</u>: Motion was made by Commissioner Brooker and seconded by Commissioner Crossen to adopt the Resolution for the ACCG 401(a) Defined Compensation and the ACCG 457(b) Deferred Compensation Plan for the benefit of eligible employees. - 2. <u>Resolution Amend the Whitfield County Defined Benefit Plan</u>: Motion was made by Commissioner Brooker and seconded by Commissioner Crossen to adopt the Resolution to Amend the ACCG Defined Benefit Plan for Whitfield County Employees. Whitfield County desires to amend the Plan and the adoption agreement effective February 1, 2016 to close the Plan to Employees hired or rehired on and after February 1, 2016 and to allow active Full-time employees on January 31, 2016 who have not me the three year eligibility period to remain eligible to participate upon meeting those requirements, and to allow certain Employees working under the SPCR contract as of December 31, 2015 who transfer employment to the County from the Public Defender's and District Attorney's Office on or before December 31, 2017 to be eligible to participate in the Plan and to receive credit for service with the State of Georgia in certain circumstances. The motion was approved 4-0, with Commissioners Brooker, Robbins, Laughter and Crossen in agreement. (SEE EXHIBIT "B")
- <u>Recreation Department Edwards Park Community Center Contract</u>: Motion was made by Commissioner Brooker and seconded by Commissioner Crossen to approve the contract with Felker Constuction Co.
