WHITFIELD COUNTY BUILDING INSPECTION PROCEDURES

POST YOUR BUILDING PERMIT ON SITE

1. If the footing is dug before initial BMPs are installed, you are subject to a Stop Work order until initial BMPs are complete.
2. All inspections require 24-hour notice. This does not mean your inspection will occur the next day. Inspections are typically conducted in the order we receive them and weather permitting.
3. Do NOT call the inspector to schedule an inspection. You MUST call the office at (706) 275-7474 to receive an inspection.
4. Have the address and permit number handy when calling to schedule an inspection.
5. Subcontractors are required to come into the office and sign the permit and pay any subcontractor fees.
6. If your inspection fails you are subject to a \$35.00 re-inspection fee. You must pay this fee before scheduling any further inspections.
